

Dear SDS Orbiana,

The Philippine Red Cross is a humanitarian organization dedicated to providing life-saving services and assistance to the most vulnerable. Here in Quezon, the PRC Chapter is a beacon of hope, working tirelessly to alleviate human suffering and uplift the lives of those in need. They are on the front lines, providing 24/7 emergency medical services, ensuring access to safe blood, and responding swiftly to emergencies and disasters, both big and small.

The PRC Quezon-Lucena City Chapter has consistently demonstrated its unwavering commitment to the community. In times of crisis, they are among the first to respond, providing critical aid and support. During storm pass through Quezon in 2020-2023, the PRC Quezon-Lucena City Chapter served a total of 1,058 hot meals, Php 14,733,500.00 worth of multi-purpose cash grant,12,739 pcs of face masks, 340 temporary shelters, 350 food relief items, 4,750 non-food relief items, and 7 schools provided CGI for restoration of school roof building.

More recently, when Typhoon Kristine struck, the PRC Quezon-Lucena City Chapter once again stepped up to help: PRC provided hot meals to 9, 979 individuals, rescued 12 individuals during operation of the typhoon here in Quezon, 300 families were provided with food and non-food items, 376 individuals undergo psychosocial support and provided child friendly spaces serving 385 children.

These are the remarkable efforts of the PRC Quezon-Lucena City Chapter's dedication to serving the community. PRC's tireless efforts make a real difference in the lives of countless individuals.


