- 1. Pursuant to Republic Act No. 7079, also known as Campus Journalism Act of 1991 released through the DepEd Order No. 94, s. 1992 which specifies the conduct of the Annual National Elementary, Secondary or Tertiary Schools Press conference and in reference to Regional Memorandum No 858, s. 2024-titled R4A CALABARZON 2025 Regional Schools Press Conference (RSPC), SDO-Lucena City through the Curriculum Implementation Division announces its PARTICIPATION TO THE 2025 REGIONAL SCHOOLS PRESS CONFERENCE (RSPC). This will be held from February 5-7 and February 10-14, 2025, and will be hosted by Batangas Cluster Schools Division Office (SDO).
- 2. The activity aims to:
 - a. Demonstrate understanding of Journalism through proficient execution in various platform like print, broadcast and online;
 - b. Recognize the role of journalism in advocating for social consciousness and environmental awareness;
 - c. Promote fair and ethical use of media as principles of responsible journalism; and

 - a. Medical Certificates of journalists and adviser
 - b. Certificate of Enrollment
 - c. School Paper for School Year 2024-2025
 - d. Parental Consent

- 4. Pre-registration online shall be from January 24 to January 31 at 5:00 p.m.
- 5. Prior to the conduct of this activity, all school paper advisers are expected to continue training the RSPC participants. They are also required to attend the cliniquing sessions every Saturday before the event.
- 6. Relative to the conduct of Journalism activities which is scheduled on Saturday this Office reiterates that DepEd personnel who will attend and serve on weekends shall be entitled to service credits as per DepEd Order No. 53, s. 2003 on "Updated Guidelines on Grant of Vacation Service Credits to Teachers" to compensate the services they render beyond working hours; likewise, Compensatory Time-off for Non-teaching Personnel based on CSM-DBM Joint Curricular No.2, s. 2004 re: Non-Monetary Renumerations for Overtime Service Rendered.
- 7. Recognizing and respecting intellectual Property Rights, this division adheres to the rule concerning plagiarism. School Papers found to have copied and published texts, graphics, and other materials without acknowledging their sources and proven by the board of judges shall be disqualified.

- 9. The 2025 RSPC will adhere to the NSPC and RSPC Guidelines. Please read DepEd Memorandum No. 858 s. 2024 for the 2025 RSPC schedule of activities, Guidelines and other requirements posted in SDO LC 2024 GC.
- 10. Expenses with regard to the conduct of this activity including food, transportation shall be charged against the Schools journalism or canteen fund, Special Education Fund or School's Maintenance and Other Operating Expenses subject to the usual accounting and auditing rules and regulations.
