MONITORING OF COMPLIANCE WITH THE ANNUAL PHYSICAL AND DENTAL EXAMINATION (APE) AND ISSUANCE OF INDIVIDUAL NOTICES FOR NON-COMPLIANCE FOR CALENDAR YEAR 2025

TO: Asst. Schools Division Superintendent Chief Education Supervisors – SGOD & CID Public Schools District Supervisors Public Elementary and Secondary School Heads All Others Concerned

- 1. Reference to the Memorandum No.156, s.2025 dated April 14, 2025, and pursuant to DepEd Order No. 28, s. 2018 and CSC Memorandum Circular No. 33, s. 1997, all teaching and non-teaching personnel in the Division of Lucena are reminded to complete their Annual Physical and Dental Examination (APE) and submit the required documents.
- 2. The APE aims to ensure early detection and prevention of illnesses among personnel, provide appropriate medical referral and support, and uphold national policies on occupational health and employee welfare.
- To ensure compliance, this Office will issue notices to personnel who fail to meet APE requirements within the deadline. School heads and unit heads are directed to facilitate the submission of required documents and report any issues encountered.
- 4. All teaching and non-teaching personnel—whether permanent, contractual, or job order—are covered by this activity. Personnel who have already completed their medical examinations and submitted all required documents are considered compliant and no further action is needed.
- 5. The revised schedule for the Annual Physical Examination (APE) is set from July 14 to September 19, 2025. (see attached Annex)
