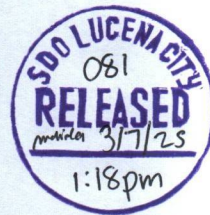

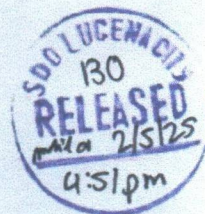

1. This Office announces the acceptance of application for Teacher I positions in the Kindergarten, Elementary, Junior High School (JHS) and Senior High School (SHS) for School Year 2025-2026.
2. The Department of Education SDO Lucena City adheres to the existing general policy of no discrimination based on gender identity, sexual orientation, disabilities, religion, and/or indigenous group membership in the implementation of its Merit Selection and Promotion Plan.
3. The guidelines for hiring and selection shall be based on the **DepEd Order No. 7 s. 2023 - Guidelines on Recruitment, Selection, and Appointment in the Department of Education** and **DepEd Order No. 21 s. 2024 – Amendments to DepEd Order No. 007 s. 2023**. The criteria are as follows:

4. All applicants shall submit photocopies of **authenticated documents** fastened in long folder with name in front to the schools located in their barangay. In the event that there are no schools in the barangay where the applicant resides, the application may be submitted to the preferred school. e. TEACHING EXPERIENCE:

- Copies of service record / certificate of employment and school clearance for those with teaching experience
- For volunteer teachers – copy of notarized memorandum of agreement signed by the SDS
- For SHS, relevant industry or work experience may be considered

f. ELIGIBILITY:

- **Authenticated** Photocopy of PRC professional identification card or a PRC certification showing the teacher's name, LET rating and other information recorded in the PRC office.
- **Authenticated** Photocopy of ratings obtained in the Licensure Examination for Teachers (LET)/Professional Board Examination for Teachers (PBET)

g. TRAINING:

- Certificate of specialized trainings acquired in the last five (5) years, if any
- For SHS, must be relevant to learning area/ specialization/ strand

h. OTHER REQUIREMENTS:

- Photocopy of Voter's ID or voter's certificate issued by the COMELEC
- Photocopy of NBI Clearance

5. Applicants shall assume full responsibility and accountability for the authenticity and veracity of the documents submitted, as evidenced by the Omnibus Sworn Statement duly signed by the applicants. Any false and fraudulent document submitted shall be grounds for disqualification.

6. Only the Letter of Intent, Personal Data Sheet, and Notarized Omnibus Certification (*Annex C*) are required to be submitted in **original** copy. All other

original copy of requirements must only be presented during the open ranking to verify the photocopies of documents submitted.

7. All applicants are **required** to register their information on this link:

8. The period of submission will be from **February 6 – February 21, 2025, only**.
9. No additional or supplemental requirements will be accepted once the period of submission is closed. The assessment and evaluation shall be based only on the available documents submitted by the applicants.
10. All teacher applicants whether or not included in the SY 2023-2024 RQA must apply again and adhere to the requirements for application.
11. The School Year (SY) 2024-2025 Comparative Assessment Result - Registry of Qualified Applicants (CAR-RQA) for Teacher I is still valid until the end of the current school year.
12. The cut-off score for inclusion in the Registry of Qualified Applicants (RQA) is **fifty (50) points**.
